Pia Pinger wins ERC Starting Grant

Cluster member Pia Pinger receives an ERC Starting Grant from the European Research Council for her project 'OPPORTUNITY – Inequalities in decisionmaking at critical junctions in life: The role of ability signals for sorting and selection'.

Pia Pinger will receive a total of 1.5 million euros over a period of five years to investigate socio-economic inequalities that emerge at critical educational and occupational junctions early in the life cycle.

New update and press release from the Greix – Joint project by Francisco Amaral (YEP Student Bonn), Moritz Schularick (IfW Kiel) and Jonas Zdrzalek (YEP Student Cologne)

The Greix is a real estate price index for Germany based on actual, notarized sales prices. It tracks the price development of individual cities and neighborhoods back to 1960 and is based on more than two million transaction data. The dataset can be used to analyze long-term trends in real estate markets and to contextualize current developments in a historical context.

Greix is a project of ECONtribute and the Kiel Institute for the World Economy (IfW Kiel) with the aim of increasing transparency in the real estate market. Different price indices for 18 cities are freely accessible at <u>www.greix.de</u>. Additional cities will gradually be added to the data set.

As shown in the latest update from 3rd of August, the downward trend for real estate prices in Germany was partially halted in the second quarter of 2023. Compared with the first quarter of 2023, many prices are even rising slightly again, although there is still a significant drop compared with the previous year and the peaks.

Price Change of the Market Segments


