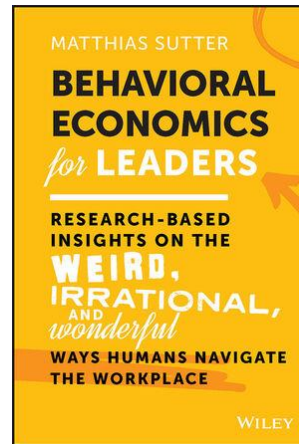


Two Special Podcast episodes

The English episode is already online, the second episode follows in the beginning of March.

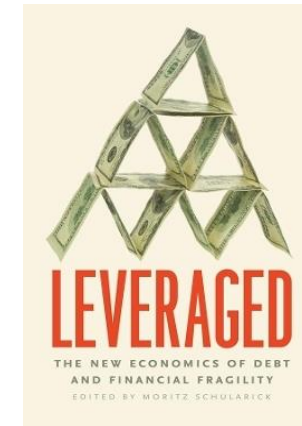
